

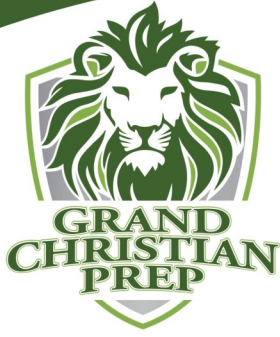

## GCP AFTER CARE POLICY

- Registration with a monthly billing commitment is required to attend GCP's After Care Program. The amount of students registered determines the number of staff needed to properly maintain this program, and GCP wants to ensure we have adequate staffing in place for the parents of Lions and Cubs who rely on an extended day.
- Parents may commit to either a daily or weekly registration by filling out the attached **After Care Commitment Form**. GCP After Care is offered from 3:30-5:30pm, Monday-Friday, excluding holidays or other days off noted on the GCP Calendar.
- Daily registration is \$10.00/day. Day(s) must be specified and committed to in advance (e.g. Monday and Wednesday; Wednesday, Thursday and Friday; just Tuesdays, etc.)
- Weekly registration is \$40.00/week.
- Registered Lions and Cubs will be billed regardless if they attend the day(s) they have signed up for or not. Registering is the **ONLY WAY** to GUARANTEE your student a spot in the After Care Program.
- Depending on demand, we will open this program to either 12 or 20 students.
- Drop ins will be available if there is room that day, however drop in status does not guarantee your student a spot. If spots are full, the drop ins will not be allowed to participate that day.
- Please submit your After Care Commitment Forms to the GCP Enrollment Specialist.
